USA Shooting Smallbore Olympic Trials Part 2 Day 1 Results

FORT BENNING, GA (May 26, 2021) – Four Olympic Team spots (two men and two women) are up for grabs at USA Shooting Smallbore Trials Part 2, May 20-26 in Ft. Benning, Georgia.

After Part 2 Day 1, Mary Tucker leads the women with an overall Olympic Smallbore Selection score of 3521. Tucker shot a score of 1183 today, only two points below the current standing national record. Sagen Maddalena follows with a score of 3515. 2016 Olympic Champion, Ginny Thrasher heads into the final day with an overall score of 3507 with Rachel McCollum right behind her in fourth with a score of 3499.

On the men's side, Patrick Sunderman leads Olympic Smallbore Trials overall on the men's side with a selection total score of 3527. Tim Sherry is right behind him with an overall score of 3523 and Peter Fiori, the NCAA athlete at Air Force Academy, heads into the final day of competition with a 3519. Nick Mowrer had the only perfect score of 400 during his prone series which helped him finish fourth overall after day 1 with a score of 3513.

Smallbore Olympic Trials Part 2, Day 2 consists of another 3x40 match plus the top eight athletes in the finals competition. Scores from part 1 plus part 2 and finals points will be added to determine the Olympic Team and Olympic Alternates.
